PUBLIC LAW NO. 21-14

AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49, 20-55, 20-62 and 20-115, by amending section 2 thereof, to change the lapse date of funds previously appropriated therein, to assist the states of Pohnpei and Yap in retiring debt and covering budget shortfalls, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 2 of Public Law No. 18-11, as amended
 by Public Laws Nos. 18-44, 19-128, 19-138, 20-11 and 20-115, is
 hereby further amended to read as follows:
- 4 "Section 2. Allotment and management of funds and lapse date. All funds appropriated by this act shall be 5 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The 9 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 10 solely for the purpose specified in this act, and that 11 no obligations are incurred in excess of the sum 12 13 appropriated. The allottee of the funds appropriated under subsection 1 of section 1 of this act shall be the 14 President of the Federated States of Micronesia or his 15 16 designee; PROVIDED THAT, the allottee of funds appropriated under subsections 1(b)(vi) 1(d)(i) and 17

2	Transportation Authority (PTA); the allottee of funds
3	appropriated under subsection 1(b)(v) of this act shall

12	authority of the allottee to obligate funds appropriated
13	by this act shall lapse on September 30, 2020."
