## AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120, 19-137, 20-29, 20-86, 20-119 and 21-31, by amending section 2 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 2 of Public Law No. 19-64, as amended
- 2 by Public Laws Nos. 19-81, 19-97, 20-86, 20-119 and 21-31, is
- 3 hereby further amended to read as follows:

4 "Section 2. Allotment and management of funds and lapse date. All funds appropriated by this act shall be 5 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The 9 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 10 solely for the purpose specified in this act, and that 11 no obligations are incurred in excess of the sum 12 13 appropriated. The allottee of the funds appropriated under section 1 of this act shall be the President of 14 the Federated States of Micronesia or his designee; 15 16 PROVIDED THAT, the funds appropriated under subsections 1(d) shall be the Mayor of Lelu Town Government or his 17

1	designee; the allottee of funds appropriated under
2	subsections $1(2)(1)(a)-(o)$ , $1(2)(2)(a)$ , $1(2)(2)(c)$ ,
3	1(2)(4)(a)-(j) shall be the Pohnpei Transportation
4	Authority (PTA); the allottee of funds appropriated
5	under subsections $1(2)(2)(b)$ , $1(2)(2)(d)$ , $1(2)(2)(e)$ and
6	1(2)(2)(f) shall be the Secretary of the Department of
7	Transportation, Communication and Infrastructure or his
8	designee; the allottee of funds appropriated under
9	subsections $1(2)(2)(g)$ , $1(2)(2)(h)$ and $1(2)(2)(l)$ shall
10	be the Pohnpei Utility Corporation; the allottee of
11	funds appropriated under subsection 1(2)(2)(m) shall be
12	the Secretary of the Department of Education or his
13	designee; the allottee of fund appropriated under
14	subsections $1(2)(4)(k)-(s)$ shall be the Governor of the
15	State of Pohnpei. The authority of the allottee to
16	obligate funds appropriated by this act shall lapse on
17	September 30, 2022."
