PUBLIC LAW NO. 21-235

AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158 and 21-186, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 4 of Public Law No. 21-43, as
2	amended by Public Laws Nos. 21-54, 21-82, 21-103 and 21-186,
3	is hereby further amended to read as follows:
4	"Section 4. Of the \$4,200,000 appropriated under this
5	act, \$1,200,000 shall be apportioned for public projects
6	and social programs for the people of Pohnpei State.

16	Section 2. Section 6 of Public Law No. 21-43, as amended by
17	Public Laws Nos. 21-54, 21-71, 21-107 and 21-158, is hereby
18	further amended to read as follows:
19	"Section 6. Allotment and management of funds and lapse
20	date. All funds appropriated by this act shall be
21	allotted, managed, administered and accounted for in
22	accordance with applicable laws, including, but not
23	limited to, the Financial Management Act of 1979. The
24	allottee shall be responsible for ensuring that these
25	funds, or so much thereof as may be necessary, are used

1	solely for the purpose specified in this act, and that no
2	obligations are incurred in excess of the sum
3	appropriated. The allottee of the funds appropriated
4	under section 2 of this act shall be the Governor of Yap
5	State or his designee; PROVIDED THAT, the allottee of
6	funds appropriated under subsection 2(f) of this act shall
7	be the President of the COM-FSM Institute. The allottee
8	of funds appropriated under sections 3 and 4 of this act
9	shall be the President of the Federated States of
10	Micronesia or his designee; PROVIDED THAT, the allottee of
11	funds appropriated under subsection 3(1) of this act shall
12	be the Governor of Kosrae State or his designee; the
13	allottee of funds appropriated under subsection 3(2) of
14	this act shall be the Mayor of Lelu Town Government or his
15	designee. The allottee of funds appropriated under
16	section 4(1) and 4(3)(1) of this act shall be the Vice
17	President; The allottee of funds appropriated under
18	subsection 4(1)(a) of this act shall be the Secretary of
19	the Department of Transportation, Communications and
20	Infrastructure or his designee, except that the allottee
21	of funds appropriated under subsections $4(2)(e)$, $4(4)(j)$,
22	4(4)(k), $4(4)(l)$ and $4(4)(m)$ of this act shall be the
23	Pohnpei Transportation Authority (PTA); the allottee of
24	funds appropriated under subsections $4(2)(1)$, $4(3)(d)$ and
25	4(3)(f) of this act shall be the Secretary of the

Department of Education or his designee; the allottee of
funds appropriated under subsection 4(2)(h) of this act
shall be the President of COM-FSM; the allottee of funds
appropriated under subsection 4(2)(m) of this act shall be
the Mayor of Nukuoro Municipal Government or his designee;
the allottee of funds appropriated under subsection
4(2)(j) of this act shall be the Secretary of the FSM
Department of Resources and Development; the allottee of
funds appropriated under subsections 4(3)(a), 4(3)(b),
4(3)(e), 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be
the Meninkeder of Madolenihmw; the allottee of funds
appropriated under subsection 4(3)(c) of this act shall be
the Chief Justice of Madolenihmw Municipal Government; the
allottee of funds appropriated under subsection 4(3)(g) of
this act shall be the Luhkenmoanlap of Kitti; the allottee
of funds appropriated under subsection 4(3)(j) of this act
shall be the Speaker of Isokonedi of Kitti; the allottee
of funds appropriated under subsection $4(3)(m)$ of this act
shall be the Director of Pohnpei Public Safety. The
allottee of the funds appropriated under sections 5(1) and
5(6) of this act shall be the Governor of Chuuk State or
his designee; the allottee of the funds appropriated under
subsection 5(2) of this act shall be the Mortlocks Island
Development Authority (MIDA); the allottee of the funds
appropriated under subsection 5(4) of this act shall be

1	the Southern Namoneas Development Authority; the allottee
2	of the funds appropriated under subsection 5(5) of this
3	act shall be the Faichuk Development Authority. The
4	allottee of funds appropriated under subsection 5(3) of
5	this act shall be the Mayor of Weno Municipal Government
6	or his designee. The authority of the allottee to
7	obligate funds appropriated by this act shall lapse on
8	September 30, 2022."
9	Section 3. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
