#### AN ACT

To further amend Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164, 20-190, 21-05 and 21-33, by amending sections 2, 3, 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Yap, Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
