AN ACT

To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding the purchase of a vessel for Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$500,000, or so much thereof as may
- be necessary, is hereby appropriated from the General Fund of
- the Federated States of Micronesia for the fiscal year ending
- September 30, 2020, for the purpose of funding the purchase of
- 5 a vessel for Chuuk State. The funds appropriated under this
- section shall be apportioned as follows:
- 1. Chuuk State purchase of vessel......\$ 500,000 7
- Section 2. Allotment and management of funds and lapse 8
- date. All funds appropriated by this act shall be allotted,
- managed, administered and accounted for in accordance with
- 11 applicable laws, including, but not limited to, the Financial
- Management Act of 1979. The allottee shall be responsible for 12
- 13 ensuring that these funds, or so much thereof as may be
- 14 necessary, are used solely for the purpose specified in this
- 15 act, and that no obligations are incurred in excess of the sum
- 16 appropriated. The allottee of the funds appropriated under
- section 1 of this act shall be the President of the Federated 17
- 18 States of Micronesia or his designee. The authority of the

1	allottee to obligate such funds shall lapse on September 30,
2	2020, and any unallotted funds will revert back to the General
3	Fund.
4	Section 3. This act shall become law upon approval by the
5	President of the Federated States of Micronesia or upon its
6	becoming law without such approval.
