- 11 Federated States of Micronesia (Annotated), as amended, provides
- 12 that for an agreement on foreign financial assistance to be valid
- 13 it must be approved by Congress by resolution; now, therefore,
- 14 BE IT RESOLVED by the Twenty-First Congress of the Federated
- 15 States of Micronesia, Fifth Special Session, 2020, that Congress
- 16 hereby approves and accepts the grant in the amount of \$1,500,000
- 17 from the World Health Organization, to fund the various health and
- 18 social programs in the FSM and to carry out the Joint Work Plan
- 19 with the World Health Organization, including all the terms and
- 20 conditions thereof; and
