To allocate the equivalent of \$20,000,000 from previous grants from the People's Republic of China not yet allocated to the Federated States of Micronesia, to fund road improvements in Pohnpei State and a new vessel for Yap State.

- 2 millions of dollars in grant funding to the Federated States of
- 3 Micronesia for the purpose of road improvements and other
- 4 assistance to meet the needs of the four states; and
- 5 WHEREAS the roads in Pohnpei are currently in need of
- 6 improvement; and
- 7 WHEREAS, Yap State is currently in need of a new vessel to
- 8 better assist its citizens dispersed throughout the outer
- 9 islands: now. therefore.
- 10 BE IT RESOLVED by the Twenty-First Congress of the
- 11 Federated States of Micronesia, Fourth Special Session, 2020,
- 12 that Congress hereby requests that \$10,000,000 of the People's
- 13 Republic of China grant money be made available to the state of
- 14 Pohnpei for road improvements within the state of Pohnpei and
- 15 \$10,000,000 of the People's Republic of China grant money be
- 16 allocated to the State of Yap for a new vessel; and
