A RESOLUTION

Approving and accepting a non-project grant aid from the Government of Japan in the amount of five hundred million Japanese Yen (\frac{4}{5}00,000,000), including all the terms and conditions of the assistance.

- 1 WHEREAS, following mutual consultations, the Japanese
- 2 Government agreed to provide five hundred million Japanese Yen
- 3 (\frac{\pi}{5}00,000,000) to the Government of the Federated States of
- 4 Micronesia for the purpose of contributing to the promotion of the
- 5 economic and social development efforts in Micronesia; and
- 6 WHEREAS, the grant is evidenced by letters exchanged and
- 7 Agreed Minutes on Procedural Details dated April 22, 2019, between
- 8 the FSM Department of Foreign Affairs and the Japanese Embassy in
- 9 Kolonia; and
- WHEREAS, the Government of the Federated States of Micronesia
- 11 wishes to express it appreciation to the Government of Japan for
- 12 the generous grant aid; and
- WHEREAS, section 210(2) of title 55 of the Code of the
- 14 Federated States of Micronesia (Annotated), as amended, requires
- 15 that for foreign financial assistance to be valid it must be
- 16 approved by Congress by resolution; now, therefore,
- 17 BE IT RESOLVED by the Twenty-First Congress of the Federated
- 18 States of Micronesia, First Special Session, 2019, that Congress
- 19 hereby approves and accepts the five hundred million Japanese Yen
- 20 (¥500,000,000) non-project grant aid from the Government Japan,
- 21 including all the terms and conditions thereof; and
