Approving and accepting a grant in the amount of \$412,163 from the U.S. Department of Interior, National Park Service, using funds from the Historic Preservation Fund under U.S. public law, including all the terms and conditions of the assistance.

- 1 WHEREAS, U.S. Department of Interior, National Park Service,
- 2 issued a Notice of Award of financial assistance on April 11,
- 3 2019, in the amount of \$412,163; and
- WHEREAS, the purpose of the grant is to support historic
- 5 preservation agencies at the national and state levels across the
- 6 Nation, and for this purpose, an amount of up to \$146,500 is for
- 7 the Pohnpei State Historic Preservation Office, the amount of
- 8 \$139,500 is for the Yap State Historic Preservation Office, the
- 9 amount of \$53,000 is for the FSM National Historic Preservation
- 10 Office, and the amount of \$73,163 is for the Kosrae State Historic

- WHEREAS, section 210(2) of title 55 of the Code of the

- 14 that for an agreement on foreign financial assistance to be valid

- WHEREAS, that the FSM Government expresses appreciation to
- 17 the United States Government for the federal grant programs made
- 18 available to the Federated States of Micronesia; now, therefore,
- BE IT RESOLVED by the Twenty-First Congress of the Federated
- 20 States of Micronesia, First Special Session, 2019, that Congress
- 21 hereby approves and accepts the \$412,163 grant from the U.S.
