Approving and accepting a grant in the amount of \$325,000 from the Government of Italy, through its Ministry of Environment, Land and Sea (IMELS), to support the Federated States of Micronesia in fulfilling its obligations under the Paris Agreement by the development of the FSM's updated Nationally Determined Contribution (NDC) for 2020, including all the terms and conditions of the assistance.

- 12 and the Clean Development Mechanism of the Kyoto Protocol" which
- was signed in May, 2007 by the Government of Italy and fourteen

- 15 WHEREAS, the Federated States of Micronesia is one of the
- fourteen Pacific Small Island Developing States privy to the 2007 16
- Memorandum of Understanding; and 17
- 18 WHEREAS, the governance of this Cooperation Program is
- entrusted to a Joint Committee which meets at the United Nations

1 in New York; and 2 WHEREAS, the Government of the Federated States of Micronesia, through its Department of Environment, Climate Change and Emergency Management, submitted a project proposal to the 5 Joint Committee to support the development of FSM's updated NDC in the amount of \$325,000; and WHEREAS, section 210(2) of title of the Code of the Federated States of Micronesia (Annotated), as amended, requires that for foreign financial assistance to be valid it must be approved Congress by resolution; now, therefore, BE IT RESOLVED by the Twenty-First Congress of the Federated 11 States of Micronesia, Seventh Special Session, 2020, that Congress 12 13 hereby approves and accepts the \$325,000 grant from the Italian 14 Ministry of Environment, Land and Sea, to support the development 15 of FSM's updated NDC for 2020, including all the terms and 16 conditions thereof; and 17 18 19 20 21 22 23 24 25
