- 3 agreement in the amount of \$15,000,000 for the purpose of funding
- 4 the Renewable Energy Development Project in the FSM; and
- 5 WHEREAS, this project will increase the FSM's energy security
- 6 and reduce reliance on fossil fuel for power generation through
- 7 investment in renewable energy generation; and
- 8 WHEREAS, section 210(2) of title 55 of the Code of the
- 9 Federated States of Micronesia (Annotated), as amended, provides
- 10 that for foreign financial assistance to be valid it must be
- 11 approved by Congress by resolution; and
- 12 WHEREAS, the FSM Government expresses its appreciation to the
- 13 Asian Development Bank for its assistance; now, therefore,
- 14 BE IT RESOLVED by the Twenty-First Congress of the Federated
- 15 States of Micronesia, Third Regular Session, 2020, that Congress
- 16 hereby approves and accepts the grant to the Federated States of
- 17 Micronesia in the amount of \$15,000,000 from the Asian Development
- 18 Bank to fund the Renewable Energy Development Project in the FSM,
- 19 including all the terms and conditions thereof; and
