
A BILL FOR AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106, 19-110, 20-108 and 21-16, by amending section 6 thereof, for the purpose of changing the allottee and lapse date of certain funds previously appropriated therein, to fund public projects and social programs in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 16-49, as amended by
2 Public Laws Nos. 17-10, 17-45, 17-85, 18-28, 18-86, 19-11, 19-106,
3 19-110, 20-108 and 21-16, is further hereby amended to read as
4 follows:

5 "Section 6. Allotment and management of funds and lapse
6 date. All funds appropriated by this act shall be
7 allotted, managed, administered and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee shall be responsible for ensuring that these
11 funds, or so much thereof as may be necessary, are used
12 solely for the purpose specified in this act, and that no
13 obligations are incurred in excess of the sum
14 appropriated. The allottee of funds appropriated under
15 sections 2 and 4 of this act shall be the President of
16 the Federated States of Micronesia or his designee;
17 PROVIDED THAT the allottee of funds appropriated under

1 section 4(1)(b) shall be the Pohnpei Transportation
2 Authority and the allottee of the funds appropriated
3 under section 4(1)(j) shall be the Mayor of Kolonia Town
4 Government. The allottee of funds appropriated under
5 section 3 of this act shall be the Governor of Yap State.
6 The allottee of funds appropriated under subsections
7 5(1)[~~7-5(3)~~], 5(6) and 5(7) of this act shall be the
8 Governor of Chuuk State or his designee. The allottee of
9 funds appropriated under subsection 5(2) of this act
10 shall be the Mortlock Islands Development Authority
11 (MIDA). The allottee of funds appropriated under
12 subsection 5(3) of this act shall be the Mayor of Weno
13 Municipal Government or his designee. The allottee of
14 funds appropriated under subsection 5(4) of this act
15 shall be the Southern Namoneas Development Authority.
16 The allottee of funds appropriated under subsection 5(5)
17 of this act shall be the Faichuk Development Authority.
18 The funds appropriated by this act shall lapse on
19 September 30, [~~2020~~] 2022."
