

A BILL FOR AN ACT

To appropriate the sum of \$1,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding Airport Facilities Improvement in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,000,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 2020, for the purpose of funding Airport Facilities Improvement
5 in each of the states. The funds appropriated under this section
6 shall be apportioned as follows:

7 Section 2. Of the \$1,000,000 appropriated under this act,
8 \$200,000 shall be apportioned for Airport Facilities Improvement in
9 the State of Yap.

12 Section 3. Of the \$1,000,000 appropriated under this act,
13 \$200,000 shall be apportioned for Airport Facilities Improvement in

1 Section 4. Of the \$1,000,000 appropriated under this act,
 2 \$300,000 shall be apportioned for Airport Facilities Improvement in
 3 the state of Pohnpei.

6 Section 5. Of the \$1,000,000 appropriated under this act,
 7 \$300,000 shall be apportioned for Airport Facilities Improvement in
 8 the state of Chuuk.

11 Section 6. Allotment and management of funds and lapse date.
 12 All funds appropriated by this act shall be allotted, managed,
 13 administered and accounted for in accordance with applicable laws,
 14 including, but not limited to, the Financial Management Act of 1979.
 15 The allottee shall be responsible for ensuring that these funds, or
 16 so much thereof as may be necessary, are used solely for the purpose
 17 specified in this act, and that no obligations are incurred in
 18 excess of the sum appropriated. The allottee of the funds
 19 appropriated under sections 2, 3, 4 and 5 of this act shall be shall
 20 be the Secretary of the Department of Transportation, Communications
 21 and Infrastructure or his designee. The authority of the allottee to
 22 obligate funds appropriated by this act shall lapse on September 30,
 23 2022.
