

A BILL FOR AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158 and 21-186, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-43, as
2 amended by Public Laws Nos. 21-54, 21-82, 21-103 and 21-186,
3 is hereby further amended to read as follows:

4 "Section 4. Of the \$4,200,000 appropriated under this
5 act, \$1,200,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

18 Section 2. Section 6 of Public Law No. 21-43, as amended by
 19 Public Laws Nos. 21-54, 21-71, 21-107 and 21-158, is hereby
 20 further amended to read as follows:

21 "Section 6. Allotment and management of funds and lapse
 22 date. All funds appropriated by this act shall be
 23 allotted, managed, administered and accounted for in
 24 accordance with applicable laws, including, but not
 25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purpose specified in this act, and that no
4 obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of Yap
7 State or his designee; PROVIDED THAT, the allottee of
8 funds appropriated under subsection 2(f) of this act shall
9 be the President of the COM-FSM Institute. The allottee
10 of funds appropriated under sections 3 and 4 of this act
11 shall be the President of the Federated States of
12 Micronesia or his designee; PROVIDED THAT, the allottee of
13 funds appropriated under subsection 3(1) of this act shall
14 be the Governor of Kosrae State or his designee; the
15 allottee of funds appropriated under subsection 3(2) of
16 this act shall be the Mayor of Lelu Town Government or his
17 designee. The allottee of funds appropriated under
18 section 4(1) and 4(3)(1) of this act shall be the Vice
19 President; The allottee of funds appropriated under
20 subsection[s] 4(1)(a) [~~and 4(2)(j)~~] of this act shall be
21 the Secretary of the Department of Transportation,
22 Communications and Infrastructure or his designee, except
23 that the allottee of funds appropriated under subsections
24 4(2)(e), 4(4)(j), 4(4)(k), 4(4)(l) and 4(4)(m) of this act
25 shall be the Pohnpei Transportation Authority (PTA); the

1 allottee of funds appropriated under subsections 4(2)(l),
2 4(3)(d) and 4(3)(f) of this act shall be the Secretary of
3 the Department of Education or his designee; the allottee
4 of funds appropriated under subsection 4(2)(h) of this act
5 shall be the President of COM-FSM; the allottee of funds
6 appropriated under subsection 4(2)(m) of this act shall be
7 the Mayor of Nukuoro Municipal Government or his designee;
8 the allottee of funds appropriated under subsection
9 4(2)(j) of this act shall be the Secretariat of the
10 Pacific Community (SPC); the allottee of funds
11 appropriated under subsections 4(3)(a), 4(3)(b), 4(3)(e),
12 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be the
13 Meninkeder of Madolenihmw; the allottee of funds
14 appropriated under subsection 4(3)(c) of this act shall be
15 the Chief Justice of Madolenihmw Municipal Government; the
16 allottee of funds appropriated under subsection 4(3)(g) of
17 this act shall be the Luhkenmoanlap of Kitti; the allottee
18 of funds appropriated under subsection 4(3)(j) of this act
19 shall be the Speaker of Isokonedi of Kitti; the allottee
20 of funds appropriated under subsection 4(3)(m) of this act
21 shall be the Director of Pohnpei Public Safety. The
22 allottee of the funds appropriated under sections 5(1) and
23 5(6) of this act shall be the Governor of Chuuk State or
24 his designee; the allottee of the funds appropriated under
25 subsection 5(2) of this act shall be the Mortlocks Island
