

A BILL FOR AN ACT

To further amend Public Law No. 20-93, as amended by Public Laws Nos. 20-98 20-120, 20-133, 21-98, 21-162 and 21-207, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 20-93, as amended by
2 Public Laws Nos. 20-98, 20-120, 20-133, 21-98, 21-162 and 21-207,
3 is hereby further amended to read as follows:

4 "Section 1. The sum of \$800,000, or so much thereof as
5 may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2018, previously
8 appropriated to fund priority infrastructure projects
9 for the state of Kosrae, to fund public projects and
10 social programs in the state of Kosrae. The funds
11 appropriated under this section shall be apportioned as
12 follows:

1 Section 2. Section 2 of Public Law No. 20-93, as amended
2 by Public Laws Nos. 20-120, 21-162 and 21-207, is hereby further
3 amended to read as follows:

4 "Section 2. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under subsections 1(a) to 1(p) of this act shall be the
15 Governor of Kosrae State or his designee. The allottee
16 of the funds appropriated under subsections 1(p) to
17 [~~1(ag)~~] 1(ah) of this act shall be the Mayor of Lelu
18 Town Government or his designee. The authority of the
19 allottee to obligate funds appropriated by this act
20 shall lapse on September 30, 2022."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
