I am transmitting the following Act, which I have signed into Public Law No. 21-156 with item veto:

Congressional Act No. 21-151, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 19-124, AS AMENDED BY PUBLIC LAWS NOS. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22 AND 21-52, BY AMENDING SECTION 4 THEREOF, TO CHANGE THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PRIORITY INFRASTRUCTURE PROJECTS AND OTHER PROGRAMS IN THE STATE OF POHNPEI, AND FOR OTHER PURPOSES."

I noted the amendments for the Madolenihmw road paving (Page 2, Line 10) and also for Pohnpei State Court vehicle (Page 3, Line 1). According to the records of the Department of Finance, the remaining funds for the two-line items are presently insufficient to accommodate the changes, leaving me no choice but item veto them.

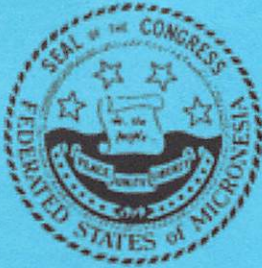

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22 and 21-52, by amending section 4 thereof, to change the use of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4. Section 4 of Public Law No. 19-
