SIXTH SPECIAL SESSION, 2020 CONGRESSIONAL BILL NO. 21-257, C.D.1, C.D.2

AN ACT

To further amend Public Law No. 20-60, as amended by Public Laws Nos. 20-65, 20-75, 20-85, 20-97, 20-150, 21-69, 21-84, 21-100 and 21-129, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-60, as
2 amended by Public Laws Nos. 20-65 and 20-75, is hereby
3 further amended to read as follows:

4 "Section 4. Of the \$4,450,000 appropriated under this
5 act, \$1,200,000 shall be apportioned for public projects
6 and social programs in the state of Pohnpei.

3 Section 2. Section 6 of Public Law No. 20-60, as amended by
4 Public Laws Nos. 20-65, 20-75, 20-97 and 21-129 is hereby further
5 amended to read as follows:

6 "Section 6. Allotment and management of funds and lapse
7 date. All funds appropriated by this act shall be
8 allotted, managed, administered and accounted for in
9 accordance with applicable laws, including, but not
10 limited to, the Financial Management Act of 1979. The
11 allottee shall be responsible for ensuring that these
12 funds, or so much thereof as may be necessary, are used
13 solely for the purpose specified in this act, and that
14 no obligations are incurred in excess of the sum
15 appropriated. The allottee of funds appropriated under
16 section 2 of this act shall be the Governor of Yap State
17 or his designee; PROVIDED THAT the allottee of funds
18 appropriated under subsections 2(i), 2(f) and 2(n) of
19 this act shall be the President or his designee. The
20 allottee of the funds appropriated under sections 3 and
21 4 of this act shall be the President of the Federated
22 States of Micronesia or his designee; PROVIDED THAT the
23 allottee of funds appropriated under subsections 3(a) to
24 3(o) of this act shall be the Mayor of Lelu Town
25 Government or his designee; the allottee of funds

1 appropriated under subsections 3(p) to 3(ae) of this act
2 shall be the Governor of Kosrae State or his designee;
3 the allottee of funds appropriated under subsections
4 4(1)(m) and 4(1)(o) of this act shall be the Mayor of
5 Pingelap or his designee; the allottee of funds
6 appropriated under subsections 4(2)(e), 4(2)(g) and
7 4(2)(m) of this act shall be the Pohnpei Transportation
8 Authority (PTA); the allottee of funds appropriated
9 under subsection 4(2)(o) of this act shall be the
10 Pohnpei Utility Corporation (PUC). The allottee of the
11 funds appropriated under subsections 5(1) and 5(6) of
12 this act shall be the Governor of Chuuk State or his
13 designee; the allottee of the funds appropriated under
14 subsection 5(2) of this act shall be the Mortlocks
15 Island Development Authority (MIDA); the allottee of
16 funds appropriated under subsection 5(3) of this act
17 shall be the Mayor of Weno Municipal Government or his
18 designee; the allottee of the funds appropriated under
19 subsection 5(4) of this act shall be the Southern
20 Namoneas Development Authority; the allottee of the
21 funds appropriated under subsection 5(5) of this act
22 shall be the Faichuk Development Authority. The
23 authority of the allottee to obligate funds appropriated
24 by this act shall lapse on September 30, 2022."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
