CONGRESSIONAL BILL NO. 21-367

AN ACT

To further amend Public Law No. 21-43, as amended by Public Laws Nos. 21-54, 21-71, 21-82, 21-103, 21-107, 21-158 and 21-186, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-43, as
2 amended by Public Laws Nos. 21-54, 21-82, 21-103 and 21-186,
3 is hereby further amended to read as follows:

4 "Section 4. Of the \$4,200,000 appropriated under this
5 act, \$1,200,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

16 Section 2. Section 6 of Public Law No. 21-43, as amended by
 17 Public Laws Nos. 21-54, 21-71, 21-107 and 21-158, is hereby
 18 further amended to read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date. All funds appropriated by this act shall be
 21 allotted, managed, administered and accounted for in
 22 accordance with applicable laws, including, but not
 23 limited to, the Financial Management Act of 1979. The
 24 allottee shall be responsible for ensuring that these
 25 funds, or so much thereof as may be necessary, are used

solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 2(f) of this act shall be the President of the COM-FSM Institute. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsection 3(1) of this act shall be the Governor of Kosrae State or his designee; the allottee of funds appropriated under subsection 3(2) of this act shall be the Mayor of Lelu Town Government or his designee. The allottee of funds appropriated under section 4(1) and 4(3)(1) of this act shall be the Vice President; The allottee of funds appropriated under subsection 4(1)(a) of this act shall be the Secretary of the Department of Transportation, Communications and Infrastructure or his designee, except that the allottee of funds appropriated under subsections 4(2)(e), 4(4)(j), 4(4)(k), 4(4)(l) and 4(4)(m) of this act shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under subsections 4(2)(l), 4(3)(d) and 4(3)(f) of this act shall be the Secretary of the


1 Department of Education or his designee; the allottee of
2 funds appropriated under subsection 4(2)(h) of this act
3 shall be the President of COM-FSM; the allottee of funds
4 appropriated under subsection 4(2)(m) of this act shall be
5 the Mayor of Nukuoro Municipal Government or his designee;
6 the allottee of funds appropriated under subsection
7 4(2)(j) of this act shall be the Secretary of the FSM
8 Department of Resources and Development; the allottee of
9 funds appropriated under subsections 4(3)(a), 4(3)(b),
10 4(3)(e), 4(3)(h), 4(3)(i) and 4(3)(k) of this act shall be
11 the Meninkeder of Madolenihmw; the allottee of funds
12 appropriated under subsection 4(3)(c) of this act shall be
13 the Chief Justice of Madolenihmw Municipal Government; the
14 allottee of funds appropriated under subsection 4(3)(g) of
15 this act shall be the Luhkenmoanlap of Kitti; the allottee
16 of funds appropriated under subsection 4(3)(j) of this act
17 shall be the Speaker of Isokonedidi of Kitti; the allottee
18 of funds appropriated under subsection 4(3)(m) of this act
19 shall be the Director of Pohnpei Public Safety. The
20 allottee of the funds appropriated under sections 5(1) and
21 5(6) of this act shall be the Governor of Chuuk State or
22 his designee; the allottee of the funds appropriated under
23 subsection 5(2) of this act shall be the Mortlocks Island
24 Development Authority (MIDA); the allottee of the funds
25 appropriated under subsection 5(4) of this act shall be

the Southern Namoneas Development Authority; the allottee of the funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority. The allottee of funds appropriated under subsection 5(3) of this act shall be the Mayor of Weno Municipal Government or his designee. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2022."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
