A BILL FOR AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49, 20-55, 20-62, 20-115, 21-14 and 21-126, by amending sections 1 and 2 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 18-11, as amended by 1 Public Laws Nos. 18-44, 19-128, 19-134, 20-11, 20-49, 20-55 and 2 3 20-62, is hereby further amended, to read as follows: "Section 1. The sum of \$1,680,000, or so much thereof as 4 5 may be necessary, is hereby appropriated from the General 6 Fund of the Federated States of Micronesia for the fiscal 7 year ending September 30, 2013, for the purpose of 8 funding public projects and social programs in the states 9 of Pohnpei and Yap. The funds shall be apportioned as 10 follows:

(1) Pohnpei State.....\$ 1,130,000
PROVIDED, HOWEVER, that the funds appropriated in
subsections (b)(c)(d) and (e) of this section shall not
be allotted until Congress is officially advised that
funds improperly disbursed as a result of the line item
veto which was reflected in Public Law No. 18-11 are
collected.

3	Section 2. Section 2 of Public Law No. 18-11, as amended by	
4	Public Laws Nos. 18-44, 19-128, 19-138, 20-11, 20-115 and 21-126,	
5	is hereby further amended to read as follows:	
6	"Section 2. Allotment and management of funds and	
7	lapse date. All funds appropriated by this act shall	
8	be allotted, managed, administered and accounted for	
9	in accordance with applicable laws, including, but not	
10	limited to, the Financial Management Act of 1979. The	
11	allottee shall be responsible for ensuring that these	
12	funds, or so much thereof as may be necessary, are	
13	used solely for the purpose specified in this act, and	
14	that no obligations are incurred in excess of the sum	
15	appropriated. The allottee of the funds appropriated	
16	under subsection 1 of section 1 of this act shall be	
17	the President of the Federated States of Micronesia or	
18	his designee; PROVIDED THAT, the allottee of funds	
19	appropriated under subsections 1(b)(vi) 1(d)(i) and	
20	1(d)(ii) 1(d)(iii) of this act shall be the Pohnpei	
21	Transportation Authority (PTA); the allottee of funds	
22	appropriated under subsection 1(b)(v) of this act	
23	shall be the Governor of the State of Pohnpei or his	
24	designee; the allotte of funds appropriated under	
25	subsections 1(b)(i), 1(b)(ii), 1(b)(iii) 1(b)(vii),

1	[and lb] <u>1</u> (b)(viii) <u>and 1(c)(iii)</u> shall be the
2	Secretary of the Department of Transportation,
3	Communications and Infrastructure or his designee.
4	The allottee of funds appropriated under subsection 2
5	of section 1 of this act shall be the Governor of the
6	State of Yap or his designee. The authority of the
7	allottee to obligate funds appropriated by this act
8	shall lapse on September 30, 2022."
9	Section 3. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
