## A BILL FOR AN ACT

To appropriate the sum of \$7,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2022, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The sum of \$7,000,000, or so much thereof as may 1 2 be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending 3 September 30, 2022, for the purpose of funding public projects and 4 5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states. The funds appropriated under this section shall be 6 apportioned as follows: 7 8 Section 2. Of the \$7,000,000 appropriated under this act,

9 \$1,000,000 shall be apportioned for public projects and social 10 programs for the people of Yap State.

State of Yap...... \$ 1,000,000 Section 3. Of the \$7,000,000 appropriated under this act, \$1,000,000 shall be apportioned for public projects and social programs for the people of Kosrae State.

20	All funds appropriated by this act shall be allotted, managed,

22	including, but not limited to, the Financial Management Act of 1979.
23	The allottee shall be responsible for ensuring that these funds, or
24	so much thereof as may be necessary, are used solely for the purpose
25	specified in this act, and that no obligations are incurred in

1 excess of the sum appropriated. The allottee of the funds 2 appropriated under section 2 of this act shall be the Governor of 3 Yap State or his designee. The allottee of funds appropriated under 4 subsection 3(1) of this act shall be the Governor of the State of 5 Kosrae or his designee; the allottee of funds appropriated under 6 subsection 3(2) of this act shall be the Mayor of Lelu Town 7 Government or his designee. The allottee of funds appropriated under 8 section 4 of this act shall be the President of the Federated States 9 of Micronesia or his designee. The allottee of the funds 10 appropriated under subsections 5(1) and 5(6) of this act shall be 11 the Governor of Chuuk State or his designee; the allottee of the 12 funds appropriated under subsection 5(2) of this act shall be the 13 Mortlocks Island Development Authority (MIDA); the allottee of funds 14 appropriated under subsection 5(3) of this act shall be the Mayor of 15 Weno Municipal Government or his designee; the allottee of the funds 16 appropriated under subsection 5(4) of this act shall be the Southern 17 Namoneas Development Authority; the allottee of the funds 18 appropriated under subsection 5(5) of this act shall be the Faichuk 19 Development Authority. The authority of the allottee to obligate 20 funds appropriated by this act shall lapse on September 30, 2024. 21 22
