## A BILL FOR AN ACT

To amend sections 304, 305 and 308 of title 50 of the Code of the Federated States of Micronesia (Annotated), as amended by P.L. No. 22-134, is hereby further amended to remove the COVID-19 Vaccination mandate for all persons entering the FSM, authorize the Department of Health and Social Affairs to reinstate COVID-19 vaccination entry requirements by regulation, technical changes, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 304 of title 50 of the Code of the 1 2 Federated States of Micronesia (Annotated), as amended, is 3 hereby amended to read as follows: 4 "Section 304. Scope of COVID-19 Vaccine [Mandate] 5 Requirements. 6 (1)[The COVID-19 vaccine mandate under this Act applies to] 7 The Secretary of the Department of Health and Social 8 Affairs shall have the authority to mandate by 9 regulation COVID-19 Vaccination requirements for all 10 persons entering the FSM, including FSM citizens and nationals, non-citizens, nonresident workers, diplomats 11 12 and ambassadors, crew on vessels or aircraft, and 13 contractual personnel of foreign governments and non-14 governmental regional or international organizations. [The] COVID-19 vaccine [mandate] requirements shall 15 (2) 16 [does] not apply to transient passengers that remain at

2	Section 2. Section 305 of title 50 of the Code of the
3	Federated States of Micronesia (Annotated), as amended, is
4	hereby amended to read as follows:
5	"Section 305. COVID-19 Vaccination and Booster
6	Requirements for Entry.
7	(1) [All persons entering the FSM shall be fully
8	vaccinated against the COVID-19 novel coronavirus
9	(SARS-CoV-2).] The Secretary of Justice, or his
10	designee, shall enforce all COVID-19 vaccination and
11	booster requirements, established through regulation by
12	the Secretary of Health pursuant to his authority under
13	Title 41 of the Code of the FSM, at all ports of entry,
14	including but not limited to:
15	(a) Type of COVID-19 vaccine and booster shotes
16	acceptable for entry into the FSM; and
17	(b) Waiting period requirements after receiving
18	the COVID-19 novel coronavirus (SARS-CoV-2) vaccine
19	and booster entry shots to be considered fully
20	vaccinated prior to entry."
21	[ <del>(2) The Secretary of Justice shall only permit the</del>
22	entry of persons into the country who are fully
23	vaccinated against COVID-19 in accordance with section
24	305 and section 307, unless the person is exempt under
25	section 306 of this Chapter."]

1 Section 3. Section 308 of title 50 of the Code of the 2 Federated States of Micronesia (Annotated), as amended, is hereby 3 amended to read as follows: 4 "Section 308. Regulation Authority. 5 The Secretary of Justice, or his designee, shall promulgate and publish such rules and regulations as 6 7 necessary to enforce the COVID-19 vaccine [mandate] 8 requirements under sections 305, 306 and 307 at all 9 ports of entry into the FSM in accordance with Chapter 1 of Title 17 of the Code of the FSM. The Secretary of 10 11 Justice shall coordinate with the Secretary of Health and the relevant departments or agencies to implement 12 regulations under this Act prior to any agency action. 13 14 The Department of Health and Department of Justice shall 15 notify all state government health authorities 30 16 business days in advance of any proposed regulations under this Act. The Secretary of Health shall have the 17 authority to enact regulations to implement this Act 18 19 pursuant to his authority under Title 41 of the Code of 20 the FSM." 21 22 23 24
