## A BILL FOR AN ACT

To further amend section 601 of title 1 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Law No. 21209, to establish FSM Law Day on July $12^{\text {th }}$ as a national holiday, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 601 of title 1 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Law No. 21-209, is hereby further amended to read as follows: "Section 601. National Holidays. The following days shall be observed as national holidays throughout the Federated States of Micronesia:
(1) the first day of January of each year, which is hereby designated as New Year's Day;
(2) the tenth day of May of each year, which is hereby designated as Federated States of Micronesia Day to commemorate the effective date of the Constitution of the Federated States of Micronesia;
(3) the third day of November of each year, which is hereby designated as Independence Day to commemorate the termination of the United Nations Trusteeship Agreement as it applied to the Federated States of Micronesia and the commencement of full self-
government for the people of the Federated States of Micronesia;
(4) the eleventh day of November of each year, which is hereby designated as Veterans Day to commemorate those who have honored their country through service in the armed forces of the United State of America;
(5) the twenty-five day of December of each year, which is hereby designated as Christmas Day;
(6) the twenty-fourth day of October of each year, which is hereby designated as United Nations Day;
(7) the thirty-first day of March of each year, which is hereby designated as Micronesian Culture and Tradition Day; [and]
(8) in honor of the first President of the Federated States of Micronesia, President Tosiwo Nakayama, who spent a lifetime in public service on a local, state, and national level, and in honor of all Presidents who have served the Federated State of Micronesia the twenty-third day of November of each year, President Tosiwo Nakayama's birthday, which is hereby designated as Presidents Day; and
(9) the twelfth day of July of each year, which is hereby designated as FSM Law Day to commemorate the date the Congress of Micronesia convened for the first time, the first Micronesian Constitution Convention

opened, citizens approved the Constitution of the Federated States of Micronesia by plebiscite, and the Supreme Court of the Federated States of Micronesia began operating."

Section 2. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
