1 allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT the allottee of funds appropriated under section 3(1) of this act shall be the Governor of Kosrae State or his designee; the allottee of funds appropriated under section 3(2) of this act shall be the Mayor of Lelu Town Government or his designee; the allottee of funds appropriated under sections 4(1), 10 4(2) and 4(3) of this act shall be the Secretary of the Department of Transportation, Communications and Infrastructure or his 11 12 designee, except that the allottee of funds appropriated under subsection 4(2)(k) of this act shall be the President of COM-FSM 13 or his designee; the allottee of funds appropriated under 14 15 subsections 4(3)(d) and 4(4)(a) of this act shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated 16 17 under subsection 4(3)(e) of this act shall be the Secretary of the Department of Health and Social Affairs or her designee. 18 allottee of the funds appropriated under subsections 5(1) and 5(6) 19 20 of this act shall be the Governor of Chuuk State or his designee; the allottee of the funds appropriated under subsection 5(2) of 21 this act shall be the Mortlocks Island Development Authority 22 (MIDA), the allottee of funds appropriated under section 5(3) of 23 this act shall be the Mayor of Weno Municipality or his designee; 24

the allottee of the funds appropriated under subsection 5(4) of
