A BILL FOR AN ACT

To further amend Public Law No. 19-64, as amended by Public Laws Nos. 19-81, 19-97, 19-120, 19-137, 20-29, 20-86, 20-119, 21-31, 21-160, 22-18, 22-72 and 22-122, by amending section 1 thereof, to change the use of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
