



AN ACT

To appropriate the sum of \$4,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. The sum of \$4,200,000, or so much thereof as may  
2 be necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 2021, for the purpose of funding public projects and  
5 social programs in each of the states. The funds appropriated  
6 under this section shall be apportioned as follows:

7       Section 2. Of the \$4,200,000 appropriated under this act,  
8 \$600,000 shall be apportioned for public projects and social  
9 programs for the people of Yap State.

5 incurred in excess of the sum appropriated. The allottee of the  
6 funds appropriated under section 2 of this act shall be the  
7 Governor of Yap State or his designee. The allottee of funds  
8 appropriated under section 3(1) of this act shall be the Governor  
9 of Kosrae State or his designee. The allottee of funds  
10 appropriated under section 3(2) shall be the Mayor Lelu Town  
11 Government or his designee. The allottee of funds appropriated  
12 under section 4 of this act shall be the Governor of Pohnpei State  
13 or his designee EXCEPT THAT, the allottee of funds appropriated  
14 under subsections 4(2)(a), 4(2)(b), 4(2)(d), 4(2)(e), 4(2)(i),  
15 4(2)(l), 4(4)(a), 4(4)(b), 4(4)(d), 4(4)(e) and 4(4)(h) of this  
16 act shall be the Pohnpei Transportation Authority (PTA); the  
17 allottee of funds appropriated under subsections 4(2)(c), 4(2)(f),  
18 4(2)(g), 4(2)(j), 4(2)(k), 4(2)(m) and 4(2)(n) of this act shall  
19 be the Secretary of the Department of Transportation,  
20 Communications and Infrastructure or his designee; the allottee of  
21 funds appropriated under subsections 4(2)(h) of this act shall be  
22 the Mayor of Kolonia Town Government or his designee; the allottee  
23 of funds appropriated under subsection 4(3)(a) of this act shall  
24 be the Luhk en Moanlap of Kitti; the allottee of funds  
25 appropriated under subsection 4(4)(f) of this act shall be the

1 Mayor of Mwokilloa Municipal Government or his designee; the  
 2 allottee of funds appropriated under subsection 4(4)(g) of this  
 3 act shall be the Mayor of Pingelap Municipal Government or his  
 4 designee. The allottee of the funds appropriated under sections  
 5 5(1) and 5(6) of this act shall be the Governor of Chuuk State or  
 6 his designee. The allottee of the funds appropriated under section  
 7 5(2) of this act shall be the Mortlock Islands Development  
 8 Authority. The allottee of the funds appropriated under section  
 9 5(3) of this act shall be the Mayor of Weno Municipal Government  
 10 or his designee. The allottee of the funds appropriated under  
 11 section 5(4) of this act shall be the Southern Namoneas  
 12 Development Authority. The allottee of the funds appropriated  
 13 under section 5(5) of this act shall be the Faichuk Development  
 14 Authority The authority of the allottee to obligate funds  
 15 appropriated by this act shall lapse on September 30, 2023.


