Dear Speaker Simina:

I am pleased to transmit herewith the enclosed Congressional Act, which I have signed to become Public Law No. 22-58:

Congressional Act No. 22-51, entitled: "AN ACT TO AMEND SECTION 131 OF TITLE 52 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA (ANNOTATED), AS AMENDED, TO CLARIFY CERTAIN PROVISIONS RELATING TO THE RECLASSIFICATION OF PUBLIC SERVICE SYSTEM POSITIONS, AND FOR OTHER PURPOSES."

This Act is amending Section 131 of Title 52 of the FSM Code by clarifying the effective date of reclassification of public service system positions. Currently, Personnel Officer has the duty and authority to classify and reclassify positions under the public service system. This Act is providing that when a reclassification is requested by a department, office or agency of the national government, the effective date of the reclassification will be the date of the request. I take this opportunity to thank the 22nd Congress for the passage of this Act to clarify the effective dates of public service system position reclassifications,





AN ACT

To amend section 131 of title 52 of the Code of the Federated States of Micronesia (Annotated), as amended, to clarify certain provisions relating to the reclassification of Public Service System positions, and for other purposes.

BE 11T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 2 Section 1. Section 131 of title 52 of the Code of the
- 3 Federated States of Micronesia (Annotated), as amended, is hereby
- 4 amended to read as follows:
- 5 "Section 131. Position Classification.
- 6 (1) All positions subject to the provisions of this chapter shall be classified by the Personnel Officer 7 according to their duties and responsibilities and shall 8 9 be grouped into classes on the basis of their 10 similarities in duties, responsibilities, and desirable qualifications. Each class shall be given a title which 11 shall apply to all positions therein, and which shall be 12 13 used for all personnel, budgetary, and financial purposes. In preparing the position classification plan, 14 the Personnel Officer shall consult with appropriate 15 management officials. The Personnel Officer may change 16 17 a position from one class to another when substantial changes have occurred in the duties and responsibilities 18

of the position. The Personnel Officer shall determine

1	the status of occupants of positions which have been
2	reclassified.
3	(2) When reclassification of a position is
4	requested by the Secretary or Director of a department,
5	office, or agency of the national government, the
6	effective date of the reclassification shall be the date
7	designated by the Secretary or Director.
8	Section 2. Effective Date. The provisions of this Act, upon
9	its approval, shall take effect retroactive to October 1, 2020.
10	Section 3. This act shall become law upon approval by the
11	President of the Federated States of Micronesia or upon becoming
12	law without such approval.
