

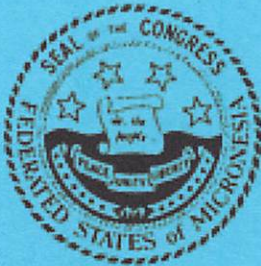
Dear President Panuelo:







CONGRESSIONAL BILL NO. 22-107

AN ACT

To further amend Public Law No. 20-178, as amended by Public Laws Nos. 21-01, 21-07, 21-36, 21-53, 21-56, 21-102, 21-115, 21-137, 21-165, 21-178, 21-200, 21-218, 21-226, 21-249 and 22-27, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-178, as amended
2 by Public Laws Nos. 21-01, 21-07, 21-53, 21-56, 21-90, 21-137,
3 21-178, 21-226 and 21-249, is hereby further amended to read as
4 follows:

5 "Section 3. Of the \$9,800,000 appropriated under this
6 act, \$1,400,000 shall be apportioned for public projects
7 and social programs for the people of Kosrae State.

4 Section 2. Section 6 of Public Law No. 21-178, as amended
5 by Public Laws Nos. 21-01, 21-36, 21-53, 21-56, 21-102, 21-137,
6 21-165, 21-218, 21-226 and 21-249, is hereby further amended to
7 read as follows:

8 "Section 6. Allotment and management of funds and lapse
9 date. All funds appropriated by this act shall be
10 allotted, managed, administered and accounted for in
11 accordance with applicable laws, including, but not
12 limited to, the Financial Management Act of 1979. The
13 allottee shall be responsible for ensuring that these
14 funds, or so much thereof as may be necessary, are used
15 solely for the purpose specified in this act, and that
16 no obligations are incurred in excess of the sum
17 appropriated. The allottee of the funds appropriated
18 under section 2 of this act shall be the Governor of Yap
19 State or his designee. The allottee of funds
20 appropriated under sections 3(a) to 3(as) of this act
21 shall be the Mayor of Lelu Town Government or his
22 designee; PROVIDED THAT the allottee of funds
23 appropriated under subsections 3(ad) and 4(2)(q) of this
24 act shall be the President of COM-FSM; the allottee of
25 funds appropriated under subsection 3(al) of this act

1 shall be the Secretary of the FSM Department of
2 Education or his designee. The allottee of funds
3 appropriated under section 4 of this act shall be the
4 President of the Federated States of Micronesia or his
5 designee; PROVIDED THAT the allottee of funds
6 appropriated under subsection 4(2)(c) of this act shall
7 be the Pohnpei Transportation Authority; the allottee of
8 funds appropriated under section 4(1) and subsection
9 4(3)(w) of this act shall be the Vice President of the
10 Federated States of Micronesia or his designee; the
11 allottee of funds appropriated under subsections
12 4(3)(a), 4(3)(b) and 4(3)(c) of this act shall be the
13 Secretary of the Department of Health and Social Affairs
14 or her designee; the allottee of funds appropriated
15 under subsections 4(3)(d), 4(3)(y) and 4(3)(z) of this
16 act shall be the Secretary of the Department of
17 Education or his designee; the allottee of funds
18 appropriated under subsections 4(3)(ab), 4(4)(f) and
19 4(3)(p) of this act shall be the Pohnpei Transportation
20 Authority, the funds appropriated under subsection
21 4(3)(g) of this act shall be the President of the
22 Federated States of Micronesia or his designee, the
23 allottee of funds appropriated under subsection 4(3)(x)
24 of this act shall be the Meninkeder Lapalap of
25 Madolenihmw Municipal Government or his designee; the

1 funds appropriated under subsections 4(3)(i), 4(3)(j) of
2 this act shall be the Secretary of the Department of
3 Transportation, Communications and Infrastructure or his
4 designee; the allottee of funds appropriated under
5 subsection 4(3)(ae) of this act shall be the Secretary
6 of the Department of Resources and Development or his
7 designee. The allottee of the funds appropriated under
8 subsections 5(1) and 5(6) of this act shall be the
9 Governor of Chuuk State or his designee; the allottee of
10 the funds appropriated under subsection 5(2) of this act
11 shall be the Mortlocks Island Development Authority
12 (MIDA); the allottee of funds appropriated under
13 subsection 5(3) of this act shall be the Mayor of Weno
14 Municipal Government or his designee; the allottee of
15 the funds appropriated under subsection 5(4) of this act
16 shall be the Southern Namoneas Development Authority;
17 the allottee of the funds appropriated under subsection
18 5(5) of this act shall be the Faichuk Development
19 Authority. The authority of the allottee to obligate
20 funds appropriated by this act shall lapse on September
21 30, 2022."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
