

TWENTY-SECOND CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND SPECIAL SESSION, 2021 CONGRESSIONAL BILL NO. 22-106, C.D.1, C.D.2

AN ACT

To further amend Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164, 20-190, 21-05, 21-33, 21-48, 21-67, 21-91, 21-182, 21-193 and 22-34, by amending sections 2, 3, and 4 thereof, to modify the use of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Yap, Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 20-141, as amended
