I am transmitting the following Congressional Act, which I have signed into Public Law No. 22-107.

CONGRESSIONAL ACT NO. 22-102, ENTITLED: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 21-80, AS AMENDED BY PUBLIC LAWS NOS. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214, 21-242, 22-19, 22-38, 22-56 AND 22-99, BY AMENDING SECTIONS 3, 4 AND 6 THEREOF, TO CHANGE THE USE, ALLOTTEE AND LAPSE DATE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF KOSRAE AND POHNPEI STATES, AND FOR OTHER PURPOSES."

However, I am vetoing line item 4(2)(q), School Buildings renovation/repair (Sokehs Powe) in the amount of \$20,000 and 4(2)(r), Supplemental funding for Palikir to COM-FSM sidewalk in the amount of \$20,000. These are based on funding certification from DOFA that the amount is fully obligated on a contract. Thank you.



AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214, 21-242, 22-19, 22-38, 22-56 and 22-99, by amending sections 3, 4 and 6 thereof, to change the use, allottee and lapse date of certain funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae and Pohnpei States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 21-80, as amended by
2 Public Laws Nos. 21-214, 21-242 and 22-38, is hereby further
3 amended to read as follows:

4 "Section 3. Of the \$4,200,000 appropriated under this
5 act, \$600,000 shall be apportioned for public projects
6 and social programs for the people of Kosrae State.

1 Section 3. Section 6 of Public Law No. 21-80, as amended by
2 Public Laws Nos. 21-99, 21-110, 21-143, 21-181 and 22-19, is
3 hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee; PROVIDED THAT, the allottee of
16 funds appropriated under subsection 2(a) of this act
17 shall be the President of COM-FSM; the allottee of funds
18 appropriated under subsections 2(c) and 2(d) of this act
19 shall be the President of the Federated States of
20 Micronesia or his designee. The allottee of funds
21 appropriated under sections 3 and 4 of this act shall be
22 the President of the Federated States of Micronesia or
23 his designee; PROVIDED THAT, the allottee of funds
24 appropriated under subsection 3(1) of this act shall be
25 the Governor of Kosrae State or his designee; the

1 allottee of funds appropriated under subsection 3(2) of
2 this act shall be the Mayor of Lelu Town Government or
3 his designee; the allottee of funds appropriated under
4 subsections 4(2) of this act shall be the Secretary of
5 the Department of Transportation, Communications and
6 Infrastructure, except that the allottee funds
7 appropriated under subsection 4(2)(f) shall be the
8 Pohnpei Port Authority (PPA); the allottee of funds
9 appropriated under subsection 4(2)(r) of this act shall
10 be the Pohnpei Transportation Authority (PTA); the
11 allottee of funds appropriated under subsections
12 4(3)(a), 4(3)(1) and 4(3)(m) of this act shall be the
13 Pohnpei Transportation Authority (PTA); the allottee of
14 funds appropriated under subsections 4(3)(b) and 4(3)(c)
15 of this act shall be the Luhkenmoanlap of Kitti; the
16 allottee of funds appropriated under subsections
17 4(3)(e), 4(3)(f), 4(3)(g) and 4(3)(o) of this act shall
18 be the Meninkeder of Madolenihmw; the allottee of funds
19 appropriated under subsections 4(3)(i) and 4(3)(j) of
20 this act shall be the Secretary of the Department of
21 Health and Social Affairs or his designee; the allottee
22 of funds appropriated under subsection 4(3)(h) of this
23 act shall be the Director of COM Land Grant Program or
24 his designee; the allottee of funds appropriated under
25 subsection 4(3)(n) of this act shall be the Vice

1 President of the Federated States of Micronesia or his
2 designee. The allottee of the funds appropriated under
3 subsections 5(1) and 5(6) of this act shall be the
4 Governor of Chuuk State or his designee; the allottee of
5 the funds appropriated under subsection 5(2) of this act
6 shall be the Mortlocks Island Development Authority
7 (MIDA); the allottee of funds appropriated under
8 subsection 5(3) of this act shall be the Mayor of Weno
9 Municipal Government or his designee; the allottee of
10 the funds appropriated under subsection 5(4) of this act
11 shall be the Southern Namoneas Development Authority;
12 the allottee of the funds appropriated under subsection
13 5(5) of this act shall be the Faichuk Development
14 Authority. The authority of the allottee to obligate
15 funds appropriated by this act shall lapse on September
16 30, 2024."
