

AN ACT

To amend title 51 of the Code of the Federated States of Micronesia (Annotated) by enacting a new section 121A to allow the hiring of nonresident workers by private sector employers, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 51 of the Code of the Federated States

of Micronesia (Annotated), is hereby amended by enacting a new

"Section 121A. Compliance with chapter;

section 121A to read as follows:

Exception for private sector employees. No 5 employer shall employ a nonresident worker except 6 7 in strict accordance with the provisions of this 8 chapter and rules and regulations issued 9 hereunder, except that the provisions of this 10 chapter shall not apply to private sector employees who are brought into the Federated 11 12 States of Micronesia for the purposes of private 13 sector employment. The exception for private 14 sector employment under this Chapter shall expire 15 on September 30, 2027."
