Dear Speaker Simina:

I am pleased to transmit the following congressional act, which I have vetoed for the reason stated in this transmittal:

Congressional Act No. 22-147, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 19-124, AS AMENDED BY PUBLIC LAWS NOS. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52, 21-146, 21-195, 21-213, 21-244, 22-62 AND 22-111, BY AMENDING SECTION 6 THEREOF, TO CHANGE THE ALLOTTEE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PRIORITY INFRASTRUCTURE PROJECTS AND OTHER PROGRAMS IN THE STATE OF POHNPEI, AND FOR OTHER PURPOSES.

I have been advised that this act involves in part the designation of two allottees for "Access road paving (Kaun and Whei, Kitti)". The designated allottees are the Luken en Moanlap of Kitti and the Pohnpei Transportation Authority. This is an invalid designation of allottees because they are separate entities—one is not under the authority of another. Given this conflicting designation of allottees, the appropriation cannot be implemented. Since I could not item-veto a designation of allottee, I have no other choice but veto the entire act and allow the FSM Congress to designate a single allottee at the next session.



AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52, 21-146, 21-195, 21-213, 21-244, 22-62 and 22-111, by amending section 6 thereof, to change the allottee of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 19-124, as amended
- 2 by Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33, 20-48,
- 3 20-63, 20-156, 21-22, 21-146, 21-195, 21-244 and 22-111, is hereby
- 4 further amended to read as follows:

"Section 6. Allotment and management of funds and 5 lapse date. All funds appropriated by this act shall 6 be allotted, managed, administered and accounted for 7 in accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are 11 used solely for the purpose specified in this act, and 12 that no obligations are incurred in excess of the sum 13 appropriated. The allottee of the funds appropriated 14 under section 2 of this act shall be the Governor of 15 the State of Yap or his designee. The allottee of the 16 funds appropriated under sections 3 and 4 of this act 17

1 shall be the President of the Federated States of 2 Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3 3(1)(a) and 3(1(b) of this act shall be the Governor 4 of Kosrae State or his designee, the allottee of funds 5 appropriated under subsections 4(1)(c), 4(1)(d), 6 4(1)(e), 4(1)(g), 4(1)(h), 4(1)(i), 4(1)(j), 4(1)(k), 7 4(1)(1), 4(1)(m), 4(1)(n), 4(1)(o), 4(2)(f), 4(3)(k), 8 4(3)(q), 4(3)(s), 4(3)(af), 4(4)(b), 4(4)(d) and 9 10 4(4)(f), shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under 11 subsections 4(1)(a), 4(1)(b), 4(1)(f), 4(2)(c), 12 4(2)(d), 4(2)(e), 4(2)(q), 4(2)(h), 4(2)(i), 4(2)(j), 13 4(3)(x), and 4(3)(0) shall be the Secretary of the 14 Department of Transportation, Communications and 15 Infrastructure or his designee; the allottee of funds 16 appropriated under subsections 4(3)(f), 4(3)(i), 17 4(3)(q) 4(3)(w) and 4(3)(aa) of this act shall be the 18 Luhk en Moanlap of Kitti, the allottee of funds 19 appropriated under subsection 4(3)(ad) of this act 20 shall be the Chief Justice of Madolenihmw or his 21 designee, the allottee of funds appropriated under 22 subsection 4(3)(ae) of this act shall be the Chief 23 Justice of Kitti or his designee. The allottee of the 24 funds appropriated under subsections 4(3)(ak) and 25

4(3)(ao) of this act shall be the Vice President of 1 2 the Federated States of Micronesia or his designee; the allottee of funds appropriated under subsection 3 4(3)(al) of this act shall be the Meninkeder Lapalap 4 of Madolenihmw Municipal Government or his designee. 5 The allottee of funds appropriated under subsections 6 5(1)(2) and 5(1)(7) of this act shall be the Governor 7 of Chuuk State or his designee; the allottee of funds 8 appropriated under subsection 5(1)(3) of this act 9 shall be the Mortlock Islands Development Authority 10 (MIDA); the allottee of funds appropriated under 11 subsections 5(1)(1) and 5(1)(4) of this act shall be 12 13 the Mayor of Weno Municipal Government or his designee; EXCEPT THAT the allottee of funds 14 appropriated under subsection 5(1)(m) of this act 15 shall be the FSM Telecommunication Corporation; the 16 allottee of funds appropriated under subsection 17 5(1)(5) of this act shall be the Southern Namoneas 18 Development Authority (SNDA); the allottee of funds 19 appropriated under subsection 5(1)(6) of this act 20 shall be the Faichuk Development Authority. 21 authority of the allottee to obligate funds 22 appropriated by this act shall lapse on September 30, 23 24 2024."
