Dear Speaker Simina:

I am pleased to transmit the following congressional act, which I have signed into Public Law No. 22–165with item veto for the reason stated in this transmittal:

Congressional Act No. 22-160, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 17-36, AS AMENDED BY PUBLIC LAWS NOS. 17-48, 17-78, 17-87, 18-36, 18-60, 18-65, 18-84, 19-22, 19-109, 20-17, 21-18, 21-124, 21-161 AND 22-126, BY AMENDING SECTION 3 THEREOF, TO CHANGE THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF KOSRAE, AND FOR OTHER PURPOSES."

I have been advised that with respect to section 3(1)(a) funding, which is for Kosrae state subsidy for renovation and maintenance", there is no longer enough fund to accommodate the change introduced in the act. This left with me no choice but item-veto this line item. Thank you.

To further amend Public Law No. 17-36, as amended by Public Laws Nos. 17-48, 17-78, 17-87, 18-36, 18-60, 18-65, 18-84, 19-22, 19-109, 20-17, 21-18, 21-124, 21-161 and 22-126, by amending section 3 thereof, to change the use of certain funds previously appropriated to fund public projects and social programs in the State of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
