
I am transmitting the following Congressional Act, which I have signed to become Public Law No. 22-17:

Congressional Act No. 22-10, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 21-157, AS AMENDED BY PUBLIC LAWS NOS 21-179 AND 21-216, BY AMENDING SECTION 2 THEREOF, TO CHANGE THE USE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF YAP STATE, AND FOR OTHER PURPOSES."

In signing this Act, I wish to advise that there is a technical error that Congress needs to address next session. Whereas, there is a decrease in appropriation in section 2(e), no corresponding increase is made anywhere in the appropriation.

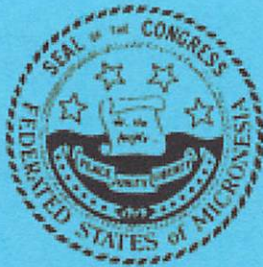

AN ACT

To amend Public Law No. 21-157, as amended by Public Laws Nos. 21-179 and 21-216, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 21-157, as amended by
2 Public Laws Nos. 21-179 and 21-216, is hereby further amended to read
3 as follows:

4 "Section 2. Of the 2,100,000 appropriated under this act,
5 \$300,000 shall be apportioned to fund public projects and
6 social programs for the people of Yap State.
