

A BILL FOR AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77, 20-113, 21-24, 21-45, 21-83, 21-101, 21-133, 21-204 and 21-220, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-31, as amended
2 by Public Laws Nos. 20-41, 20-113, 21-45 and 21-204, is hereby
3 further amended to read as follows:

4 "Section 3. Of the sum of \$4,200,000 appropriated by
5 this act, \$600,000 is apportioned for Kosrae State for
6 public projects and social programs.

19 Section 2. Section 6 of Public Law No. 20-31, as amended
 20 by Public Laws Nos. 20-41, 21-24, 21-83 and 21-133, is hereby
 21 further amended to read as follows:

22 "Section 6. Allotment and management of funds and
 23 lapse date. All funds appropriated by this act
 24 shall be allotted, managed, administered and
 25 accounted for in accordance with applicable laws,

1 including, but not limited to, the Financial
2 Management Act of 1979. The allottee shall be
3 responsible for ensuring that these funds, or so
4 much thereof as may be necessary, are used solely
5 for the purpose specified in this act, and that no
6 obligations are incurred in excess of the sum
7 appropriated. The allottee of the funds
8 appropriated under section 2 of this act shall be
9 the Governor of Yap State or his designee. The
10 allottee of funds appropriated under sections 3 and
11 4 of this act shall be the President of the
12 Federated States of Micronesia or his designee;
13 PROVIDED THAT the allottee of funds appropriated
14 under subsections 3(a) to 3(n) of this act shall be
15 the Mayor of Lelu Town Government or his designee;
16 the allottee of funds appropriated under
17 subsections [~~3(o) to 3(ae)~~] 3(p) to 3(ah) of this
18 act shall be the Governor of Kosrae State or his
19 designee; EXCEPT THAT, the allottee of funds
20 appropriated under subsection 3(af) of this act
21 shall be the Mayor of Lelu Town Government or his
22 designee; the allottee of funds appropriated under
23 subsections 3(o) and 3(ai) of this act shall be the
24 Mayor of Utwe Municipal Government or his designee;
25 the allottee of funds appropriated under

1 subsections 4(1)(f), 4(1)(k), 4(1)(l), 4(1)(m),
2 4(2)(b) and 4(2)(c) of this act shall be the
3 Pohnpei Transportation Authority (PTA); the
4 allottee of funds appropriated under subsections
5 4(2)(a), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(g),
6 4(2)(h), 4(2)(i) and 4(2)(j) shall be the Secretary
7 of the Department of Transportation, Communications
8 and Infrastructure or his designee; 4(3)(g),
9 4(3)(v) and 4(3)(w) of this act shall be the
10 Secretary of Education or his designee; the
11 allottee of funds appropriated under subsections,
12 4(3)(l) and 4(3)(t) of this act shall be the
13 Luhkenmoanlap of Kitti; the allottee of funds
14 appropriated under subsection 4(3)(o) of this act
15 shall be the Pohnpei Utility Corporation; the
16 allottee of funds appropriated under subsection
17 4(3)(j) of this act shall be the Speaker of
18 Madolenihmw Municipal Government or his designee;
19 the allottee of funds appropriated under subsection
20 4(3)(p) of this act shall be the Director of Land
21 Grant Program; the allottee of funds appropriated
22 under subsection 4(3)(r) of this act shall be the
23 Secretary of Health and Social Affairs or her
24 designee; the allottee of funds appropriated under
25 subsection 4(3)(u) of this act shall be the

1 Meninkeder of Madolenihmw. The allottee of funds
2 appropriated under subsections 5(1) and 5(6) of
3 this act shall be the Governor of Chuuk State or
4 his designee. The allottee of funds appropriated
5 under subsection 5(2) of this act shall be the
6 Mortlock Islands Development Authority. The
7 allottee of funds appropriated under subsection
8 5(3) of this act shall be the Mayor of Weno
9 Municipal Government or his designee. The allottee
10 of funds appropriated under subsection 5(4) of this
11 act shall be the Southern Namoneas Development
12 Authority. The allottee of funds appropriated
13 under subsection 5(5) of this act shall be the
14 Faichuk Development Authority. The authority of
15 the allottee to obligate funds appropriated by this
16 act shall lapse on September 30, 2022.”

17 Section 3. This act shall become law upon approval by the
18 President of the Federated States of Micronesia or upon its
19 becoming law without such approval.
