

A BILL FOR AN ACT

To appropriate the sum of \$11,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2022, for the purpose of funding priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$11,200,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2022, for the purpose of funding priority
5 infrastructure projects and other public projects and social
6 programs for the people of Yap, Kosrae, Pohnpei and Chuuk states.
7 The funds appropriated under this section shall be apportioned as
8 follows:

9 Section 2. Of the \$11,200,000 appropriated under this act,
10 \$1,600,000 shall be apportioned for priority infrastructure
11 projects and other public projects and social programs for the
12 people of Yap State.

13 State of Yap..... \$ 1,600,000

14 Section 3. Of the \$11,200,000 appropriated under this act,
15 \$1,600,000 shall be apportioned for priority infrastructure
16 projects and other public projects and social programs for the
17 people of Kosrae State.

18 State of Kosrae 1,600,000

3 Section 4. Of the \$11,200,000 appropriated under this act,
 4 \$3,200,000 shall be apportioned for priority infrastructure
 5 projects and other public projects and social programs for the
 6 people of Pohnpei State.

8 (1) At Large..... 800,000

9 (2) Election District No. 1..... 800,000

10 (3) Election District No. 2..... 800,000

11 (4) Election District No. 3 800,000

12 Section 5. Of the \$11,200,000 appropriated under this act,
 13 \$4,800,000 shall be apportioned for priority infrastructure
 14 projects and other public projects and social programs for the
 15 people of Chuuk State.

16 State of Chuuk..... 4,800,000

17 (1) At Large..... 800,000

18 (2) Election District No. 1..... 800,000

19 (3) Election District No. 2..... 800,000

20 (4) Election District No. 3 800,000

21 (5) Election District No. 4 800,000

23 Section 6. Allotment and management of funds and lapse date.
 24 All funds appropriated by this act shall be allotted, managed,
 25 administered and accounted for in accordance with applicable laws,

1 including, but not limited to, the Financial Management Act of 1979.
2 The allottee shall be responsible for ensuring that these funds, or
3 so much thereof as may be necessary, are used solely for the purpose
4 specified in this act, and that no obligations are incurred in
5 excess of the sum appropriated. The allottee of the funds
6 appropriated under section 2 of this act shall be the Governor of
7 Yap State or his designee. The allottee of funds appropriated under
8 subsection 3(1) of this act shall be the Governor of the State of
9 Kosrae or his designee; the allottee of funds appropriated under
10 subsection 3(2) of this act shall be the Mayor of Lelu Town
11 Government or his designee. The allottee of funds appropriated
12 under section 4 of this act shall be the President of the Federated
13 States of Micronesia or his designee. The allottee of the funds
14 appropriated under subsections 5(1) and 5(6) of this act shall be
15 the Governor of Chuuk State or his designee; the allottee of the
16 funds appropriated under subsection 5(2) of this act shall be the
17 Mortlocks Island Development Authority (MIDA); the allottee of funds
18 appropriated under subsection 5(3) of this act shall be the Mayor of
19 Weno Municipal Government or his designee; the allottee of the funds
20 appropriated under subsection 5(4) of this act shall be the Southern
21 Namoneas Development Authority; the allottee of the funds
22 appropriated under subsection 5(5) of this act shall be the Faichuk
23 Development Authority. The authority of the allottee to obligate
24 funds appropriated by this act shall lapse on September 30, 2024.

1 Section 7. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
