

A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as may  
2 be necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 2021, for the purpose of funding public projects and  
5 social programs for the people of Yap, Kosrae, Pohnpei and Chuuk  
6 states. The funds appropriated under this section shall be  
7 apportioned as follows:

8 Section 2. Of the \$2,800,000 appropriated under this act,  
9 \$400,000 shall be apportioned for public projects and social  
10 programs for the people of Yap State.

12 Section 3. Of the \$2,800,000 appropriated under this act,  
13 \$400,000 shall be apportioned for public projects and social  
14 programs for the people of Kosrae State.

15 state of Kosrae.....\$ 400,000

16 (1) At Large..... 200,000

17 (2) Election District No. 1 200,000

1 Section 4. Of the \$2,800,000 appropriated under this act,  
 2 \$800,000 shall be apportioned for public projects and social  
 3 programs for the people of Pohnpei State.

9 Section 5. Of the \$2,800,000 appropriated under this act,  
 10 \$1,200,000 shall be apportioned for public projects and social  
 11 programs for the people of Chuuk State.

19 Section 6. Allotment and management of funds and lapse date.  
 20 All funds appropriated by this act shall be allotted, managed,  
 21 administered and accounted for in accordance with applicable laws,  
 22 including, but not limited to, the Financial Management Act of  
 23 1979. The allottee shall be responsible for ensuring that these  
 24 funds, or so much thereof as may be necessary, are used solely for  
 25 the purpose specified in this act, and that no obligations are

1 incurred in excess of the sum appropriated. The allottee of the  
2 funds appropriated under section 2 of this act shall be the  
3 Governor of Yap State or his designee. The allottee of funds  
4 appropriated under sections 3 and 4 of this act shall be the  
5 President of the Federated States of Micronesia or his designee.  
6 The allottee of the funds appropriated under subsections 5(1),  
7 5(3) and 5(6) of this act shall be the Governor of Chuuk State or  
8 his designee; the allottee of the funds appropriated under  
9 subsection 5(2) of this act shall be the Mortlocks Island  
10 Development Authority (MIDA); the allottee of the funds  
11 appropriated under subsection 5(4) of this act shall be the  
12 Southern Namoneas Development Authority; the allottee of the funds  
13 appropriated under subsection 5(5) of this act shall be the  
14 Faichuk Development Authority. The authority of the allottee to  
15 obligate funds appropriated by this act shall lapse on September  
16 30, 2023."

17 Section 7. This act shall become law upon approval by the  
18 President of the Federated States of Micronesia or upon its  
19 becoming law without such approval.
