A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the U.S. Department of Health and Human Services, Administration for Children and Families, to fund the State Personal Responsibility Education Program (SPREP), including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services
2 issued a Grant Award on June 4, 2021, to the Government of the
3 Federated States of Micronesia providing funding in the amount of
4 \$250,000 for the purpose of providing support for the
5 implementation of the State Personal Responsibility Education
6 Program (SPREP); and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by Congress
9 through resolution; and

10 WHEREAS, the Government of the Federated States of Micronesia
11 wishes express its appreciation and gratitude to the Department of
12 Health and Human Services and the U.S. Government for extending
13 this grant; now, therefore,

14 BE IT FURTHER RESOVED that the Twenty-Second Congress of the
15 Federated States of Micronesia, First Special Session, 2021, that
16 Congress hereby approves and accepts the \$250,000 grant from U.S.
17 Department of Health and Human Services, including all the terms
18 and conditions thereof; and

2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the Department of Justice and the
4 Secretary of the Department of Foreign Affairs.


