A RESOLUTION

Approving and accepting a grant in the amount of \$165,504 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), to fund and support the project entitled "Epidemiology and Laboratory Capacity for Infectious Diseases (ELC) in the Federated States of Micronesia", including all the terms and conditions of the assistance.

1 WHEREAS, on June 29, 2021, the United States of America,
2 through its Department of Health and Human Services, Centers for
3 Disease Control and Prevention (CDC), extended to the Government
4 of the Federated States of Micronesia, through its Department of
5 Health and Social Affairs, a grant in the amount of \$165,504 as
6 evidenced in the Notice of Grant Award No. 5 NU50CK000513-00; and

7 WHEREAS, the Government of the Federated States of Micronesia
8 wishes to express its sincere gratitude to the Government of the
9 United States of America for this generous grant; and

10 WHEREAS, the grant was awarded for the specific purpose of
11 funding the project entitled "Epidemiology and Laboratory Capacity
12 for the Infectious Disease (ELC)" and related services to support
13 capacity development for emerging infectious disease control in
14 the FSM; and

15 WHEREAS, the project period is from August 1, 2019 to July
16 31, 2024, and the budget period for this grant is from August 1,
17 2021, through to July 30, 2022; and

1 WHEREAS, section 210(2) of title 55 of the Code of the
2 Federated States of Micronesia (Annotated), requires for foreign
3 financial assistance to be valid it must be approved by Congress
4 by resolution, now, therefore,

5 BE IT RESOLVED by the Twenty-Second Congress of the Federated
6 States of Micronesia, First Special Session, 2021, that Congress
7 hereby approves and accepts the \$165,504 grant from the U.S.
8 Department of Health and Human Services, Centers for Disease
9 Control and Prevention, including all the terms and conditions
10 thereof; and

11 BE IT FURTHER RESOLVED that certified copies of this
12 resolution be transmitted to the President of the Federated States
13 of Micronesia, the Secretary of the Department of Health and
14 Social Affairs, the Secretary of the Department of Foreign
15 Affairs, and the Secretary of the Department of Justice.


