Approving and accepting a grant in the amount of \$1,270,615 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), to fund and support the project entitled: "Immunization and Vaccines for Children", including all the terms and conditions of the assistance.

1 WHEREAS, on July 08, 2021, the United States Department of
2 Health and Human Services, Health and Human Services, Centers for
3 Disease Control and Prevention (CDC), extended to the Government
4 of the Federated States of Micronesia, through its Department of
5 Health and Social Affairs, a grant in the amount of \$1,270,615 as
6 evidenced in the Notice of Grant Award No. 5 NH23IP922593; and

7 WHEREAS, the purpose of this grant is to fund and support FSM
8 Department of Health and Social Affairs in the ongoing
9 implementation of its project entitled "Immunization and Vaccines
10 for Children"; and

11 WHEREAS, the project period is from July 1, 2019, to June 30,
12 2024, and the budget period for this grant is from July 1, 2021
13 through to June 30, 2022; and

14 WHEREAS, section 210(2) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, requires
16 that for foreign financial assistance to be valid it must be
17 approved by Congress by resolution, now, therefore,

18 BE IT RESOLVED by the Twenty-Second Congress of the Federated
19 States of Micronesia, First Special Session, 2021, that Congress

1 hereby approves and accepts the \$1,270,615 grant from the U.S.
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, to fund the Immunization and Vaccines for
4 Children Project including all the terms and conditions thereof;
5 and

6 BE IT FINALLY RESOLVED that certified copies of this
7 resolution be transmitted to the President of the Federated States
8 of Micronesia, the Secretary of the Department of Health and
9 Social Affairs, the Secretary of the Department of Foreign
10 Affairs, the Secretary of the Department of Finance and
11 Administration and the Secretary of the Department of Justice.
