2 Second the President submitted the nomination of Mrs. Jane J.
3 Chigiyal to serve as the Permanent Representative of the Federated
4 States of Micronesia to the United Nations; and

5 WHEREAS the resolution approving the nomination has not been
6 adopted by Congress; and

7 WHEREAS, under 2 F.S.M.C. section 207, the nomination may not
8 be resubmitted by the President during the Twenty-Second Congress
9 without authorization from Congress; now, therefore,

10 BE IT RESOLVED by the Twenty-Second Congress of the Federated
11 States of Micronesia, First Special Session, 2021, that Congress
12 hereby authorizes the President to resubmit the nomination of Mrs.
13 Jane J. Chigiyal to serve as the Permanent Representative of the
14 Federated States of Micronesia to the United Nations; and


