A RESOLUTION

To approve and accept a \$706,745 grant from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, to fund and support the FSM Substance Abuse Prevention and Treatment (SAPT) Block Grant, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services
2 issued a Grant Award on June 30, 2021, to the Government of the
3 Federated States of Micronesia providing funding in the amount of
4 \$706,745 for the purpose of providing support to the FSM Substance
5 Abuse Prevention and Treatment (SAPT) Block Grant; and

6 WHEREAS, this grant is considered a foreign financial
7 assistance that requires for its validity the approval by Congress
8 through resolution; and

9 WHEREAS, that the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to the
11 U.S. Government for extending this grant; now, therefore,

12 BE IT RESOLVED by the Twenty-Second Congress of the Federated
13 States of Micronesia, Second Special Session, 2021, that Congress
14 hereby approves and accepts the \$706,745 grant from U.S.

15 Department of Health and Human Services, to fund the FSM SAPT
16 Block Grant, including all the terms and conditions thereof; and


