To approve and accept a \$234,421 grant from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration to provide support to the FSM Block Grants for Community Mental Health Services, including all the terms and conditions of the assistance.


1 BE IT FURTHER RESOLVED that certified copies of this


