1 WHEREAS, on October 12, 2021, U.S. Department of Interior,
2 Office of Insular Affairs, issued a grant to the Federated States
3 of Micronesia in the amount of \$500,000; and

4 WHEREAS, the purpose of the grant is to provide funding for
5 the FSM Single Audit for Fiscal Year 2021 as required under the
6 Amended Compact; and

7 WHEREAS, the grant is subject to the approval of Congress by
8 resolution; and

9 WHEREAS, the Government of the Federated States of Micronesia
10 wishes to express its appreciation to the Government of the United
11 States for the grant; now, therefore,

12 BE IT RESOLVED by the Twenty-Second Congress of the Federated
13 States of Micronesia, Second Special Session, 2021, that Congress
14 hereby approves and accepts the \$500,000 grant from the U.S.
15 Department of Interior, Office of Insular Affairs, to fund the FSM
16 Single Audit for Fiscal Year 2021; and




