

A RESOLUTION

Expressing the sincere gratitude and appreciation of the Twenty-Second Congress of the Federated States of Micronesia to Mr. Yancy B. Cottrill for his dedicated service as a staff attorney to the Congress of the Federated States of Micronesia.
