A BILL FOR AN ACT

To further amend section 404 of title 24 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Laws Nos. 19-169 and 21-93, by reducing the Fishing Aggregated Device (FAD) closure to a one and half months from July to mid-August, prohibition of deploying, servicing or setting on FADs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 404 of title 24 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended by Public
- 3 Law No. 19-169, is hereby further amended to read as follows:
- 4 "Section 404. Access agreements-minimum terms and
- 5 conditions.
- 6 (A) All access agreements shall include the following
 7 minimum terms:
- 8 (1) the foreign party recognizes the sovereign rights
 9 and exclusive fishery management authority of the
 10 Federated States of Micronesia within the exclusive
- 12 (2) the operator and each member of the crew shall
 13 comply with the applicable access agreement, applicable
- 14 permit conditions, this subtitle, all regulations issued
- pursuant to this subtitle and all other applicable laws
- and regulations; (3) the operator shall:

1	(b) provide any authorized observer, while on
2	board the vessel, at no expense, with officer level
3	accommodations, food and medical facilities;
4	(c) meet the following costs of the authorized
5	observer:
6	(i) full travel costs to and from the
7	vessel;
8	(ii) salary; and
9	(iii) full insurance coverage;
10	(d) display any permit or permit number issued
11	for any such vessel, pursuant to this subtitle, or any
12	other documentation as required by the Authority to be
13	displayed, under any access agreement, in the wheelhouse
14	of such vessel;
15	(e) ensure that appropriate position-fixing and
16	identification equipment is installed and maintained in
17	working order on each vessel;
18	(f) ensure that the vessel is marked and
19	identified in accordance with the Food and Agricultural
20	Organization (FAO) approved Standard Specifications for
21	the Marking and Identification of Fishing Vessels;
22	(g) ensure the continuous monitoring of the
23	international distress and call frequency 2182 kHz (HF)
24	or the international safety and call frequency 156.8 MHz
25	(channel 16, VHF-FM) to facilitate communication

with the fisheries management, surveillance and
enforcement authorities;

- (h) ensure that a recent and up-to-date copy of the International Code of Signals (INTERCO) is on board and accessible at all times;
- (i) ensure that the vessel is seaworthy and contains adequate life safety equipment and survival gear for each passenger and member of the crew;
- (j) ensure that, promptly upon direction by the Authority, each vessel will have installed, maintained and fully operational at all times on board a transponder, in accordance with section 611 of chapter 6 of this subtitle, and shall be responsible for all operational and maintenance costs of the transponder and cooperate fully with the Authority in their utilization.
- (4) the party to the access agreement shall, for the duration of the access agreement:
- (a) appoint and maintain a resident agent in the Federated States of Micronesia that is approved by the Authority, or establish and maintain a company registered in accordance with the laws of the Federated States of Micronesia, authorized to receive and respond to any legal process issued in the Federated States of Micronesia with respect to the owner or operator of the

vessel, and shall notify the Federated States of
Micronesia of the name and address of such agent or
company, and any communication, information, document,
direction, request or response to, or from that agent or
company, shall be deemed to have been sent to, or
received from such owner or operator;

- (b) not exceed any allocation which may be established in any given licensing period in accordance with this subtitle;
- (c) ensure compliance by each fishing vessel, its operator and crew members, with the access agreement, all laws of the Federated States of Micronesia and the terms of the permit; and
- (d) ensure compliance by each fishing vessel, its operator and crew members, with sub regional and regional conservation and management measures for highly migratory fish stocks.
- (B) On such further terms and conditions as may be modified or expanded by regulation promulgated by the Authority in accordance with the Administrative Procedures Act, the following terms and conditions are mandatory to every access agreement:
- (1) Catch retention. All bigeye, skipjack and yellowfin tuna taken by a purse seine vessel shall be retained on board and then landed or transshipped in

1	accordance with this title, except for:
2	(a) fish clearly and demonstrably unfit for
3	human consumption; and
4	(b) the final set of a trip where the Authority
5	has authorized net-sharing.
6	It is the duty of Master of fishing vessel to report
7	fish discard under (1) (a) and (b) of this subsection.
8	(2) Use of fish aggregating device. There shall be
9	no deployment or servicing of fish aggregating device
10	and associated electronic equipment, or fishing by purse
11	seine vessels on floating objects, between 0001 hours
12	$[\frac{\text{GMT}}]$ $\underline{\text{UTC}}$ on 1 July and 2359 hours $[\frac{\text{GMT}}]$ $\underline{\text{UTC}}$ on $[\frac{30}]$
13	September] 15 August each year, except that:
14	(a) by regulation, the Authority may grant
15	exemption to fishing vessels that have suffered
16	disproportionate burden from the prohibition on the use
17	of fish aggregating device; and
18	(b) by regulation, the Authority may provide for
19	appropriate arrangement set out in a FAD management plan
20	to meet the requirements of domestic fishing vessels
21	that are highly dependent on fishing on floating
22	objects.
23	(3) Closure of high seas areas. A fishing vessel
24	shall not fish the areas listed below:
25	(a) the area of high seas bounded by the

1	national waters of the Federated States of Micronesia,
2	Indonesia, Palau, and Papua New Guinea; and
3	(b) the area of high seas bounded by the
4	national waters of the Federated States of Micronesia,
5	Fiji, Kiribati, the Marshall Islands, Nauru, Papua New
6	Guinea, the Solomon Islands, and Tuvalu.
7	(c) On a case-by-case basis, the Authority may
8	exercise discretionary exemption from this prohibition."
9	Section 2. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
