
A BILL FOR AN ACT

To further amend Public Law No. 21-180, as amended by Public Laws Nos. 21-191, 21-234, 21-240 and 22-21, by amending section 6 thereof, to change the allottee and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 21-180, as amended by
2 Public Laws Nos. 21-191, 21-234, 21-240, 22-21 and 22-131, is
3 hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee. The allottee of funds
16 appropriated under sections 3 and 4 of this act shall be
17 the President of the Federated States of Micronesia or

1 his designee; PROVIDED THAT; the allottee of funds
2 appropriated under subsections 4(1)(b) and 4(1)(c) of
3 this act shall be the Secretary of the Department of
4 Health and Social Affairs or his designee; the allottee
5 of funds appropriated under subsection 4(1)(d) of this
6 act shall be the Secretary of the Department of Justice
7 or his designee; the allottee of funds appropriated
8 under subsection 4(1)(e) of this act shall be the
9 Secretary of the Department of Resources and Development
10 or his designee; the allottee of funds appropriated
11 under section 3(1) of this act shall be the Governor of
12 Kosrae State or his designee; the allottee of funds
13 appropriated under subsection 3(2) of this act shall be
14 the Mayor of Lelu Town or his designee; the allottee of
15 funds appropriated under subsections 4(1)(a), 4(1)(f),
16 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(f),
17 4(2)(g), and 4(2)(h) [~~and 4(3)(e)~~] of this act shall be
18 the Secretary of the Department of Transportation,
19 Communications and Infrastructure; the allottee of funds
20 appropriated under subsection 4(3)(c) of this act shall
21 be the Governor of Pohnpei State or his designee; the
22 allottee of funds appropriated under subsection 4(2)(i)
23 of this act shall be the Chief Magistrate of Sokehs
24 Municipal Government; the allottee of funds appropriated
25 under subsections 4(3)(a) of this act shall be the

1 Pohnpei Transportation Authority (PTA); the allottee of
2 funds appropriated under subsection 4(3)(e) of this act
3 shall be the Vice President of the Federated States of
4 Micronesia or his designee; the allottee of funds
5 appropriated under subsection 4(3)(b) of this act shall
6 be the Luhken Moanlap of Kitti; the allottee of funds
7 appropriated under [~~subsections 4(3)(b) and~~] subsection
8 4(3)(d) of this act shall be the Meninkeder of
9 Madolenihmw. The allottee of funds appropriated under
10 section 5(1) of this act shall be the At-large office.
11 The allottee of the funds appropriated under
12 [~~subsections 5(1) and~~] 5(6) of this act shall be the
13 Governor of Chuuk State or his designee; the allottee of
14 the funds appropriated under subsection 5(2) of this act
15 shall be the Mortlocks Island Development Authority
16 (MIDA), the allottee of funds appropriated under section
17 5(3) of this act shall be the Mayor of Weno Municipal
18 Government or his designee; the allottee of the funds
19 appropriated under subsection 5(4) of this act shall be
20 the Southern Namoneas Development Authority; the
21 allottee of the funds appropriated under subsection 5(5)
22 of this act shall be the Faichuk Development Authority.
23 The authority of the allottee to obligate funds
24 appropriated by this act shall lapse on September 30,
25 [~~2024~~] 2026."

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
