A BILL FOR AN ACT

To amend Public Law No. 21-228, as amended by Public Laws Nos. 21-248, 22-12, 22-22, 22-36, 22-74, 22-90 and 23-18, by amending section 6 thereof, to change the lapse date of funds appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 21-228, as amended by
- Public Law No. 21-248, is hereby further amended to read as
- 3 follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 10 solely for the purpose specified in this act, and that no 11 obligations are incurred in excess of the sum 12 13 appropriated. The allottee of the funds appropriated 14 under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds appropriated 15 under sections 3 and 4 of this act shall be the President 16 of the Federated States of Micronesia or his designee, 17 PROVIDED THAT the allottee of funds appropriated under 18

subsection 3(1) of this act shall be the Governor of Kosrae State or his designee; the allottee of funds appropriated under subsection 3(2) of this act shall be the Mayor of Lelu Town Government or his designee; the allottee of funds appropriated under subsections 4(1) and 4(2) of this act shall be the Secretary of the Department of Transportation, Communications and Infrastructure or his designee; EXCEPT THAT the allottee of funds appropriated under subsection 4(1)(b) of this act shall be the Secretary of the Department of Education or his designee; the allottee of funds appropriated under subsection 4(2)(f) of this act shall be the Pohnpei Transportation Authority and the allottee of funds appropriated under subsection 4(2)(m) of this act shall be the President of the COM-FSM; the allottee of funds appropriated under subsection (4)(3) of this act shall be the Pohnpei Transportation Authority; EXCEPT THAT the allottee of funds appropriated under subsections 4(3)(i) and 4(3)(j) of this act shall be the Luhken Menlap of Kitti or his designee; and the allottee of funds appropriated under subsection 4(3)(k) of this act shall be the President of the Federated States of Micronesia of his The allottee of funds appropriated under designee. subsections 4(4)(d) and 4(4)(e) of this act shall be the Pohnpei Transportation Authority; the allottee of funds
