A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia (Annotated), as amended, by amending sections 630, 631 and 632 thereof, for the purpose of changing the name, nature and use of the purpose of the Fisheries Observer Revolving Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 630 of title 55 of the Code of the Federated States of Micronesia, is hereby amended to read as 2 3 follows: 4 "Section 630. Establishment. Purpose. 15 provide an ongoing revolving and cost recovery fund for 16 the receipt and disbursement of funds associated with

Programs, which include the fisheries observer and port

11	follows:	
12		"Section 632. <u>Deposits</u> . All future appropriations for
13		the Fund as well as revenues or funds received for
14		NORMA's Compliance, Conservation, and Monitoring
15		Programs, pursuant to the provisions of section 403(2)
16		of title 24 of this code shall deposited in the Fund.
17		Any unexpended moneys in this Fund shall not revert to
18		the General Fund nor lapse at the end of the fiscal
19		year[; PROVIDED, HOWEVER, that any amount in excess of
20		\$1,000,000 shall be paid into the General Fund].
