## A BILL FOR AN ACT

To further amend Public Law No. 21-201, as amended by Public Laws Nos. 21-219, 21-223, 21-229, 21-241, 22-14, 22-28, 22-31, 22-51, 22-67, 22-104 and 23-21, by amending section 4 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs for the people of Pohnpei State, and for other purposes.
