A BILL FOR AN ACT

To amend title 3 of the Code of the Federated States of Micronesia (Annotated), by creating a new chapter 8 to establish the procedures for a member of Congress' voluntary relinquishment of a congressional seat, declaration of congressional seat vacancy following voluntary relinquishment of congressional seat, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 3 of the Code of the Federated States of

2 Micronesia (Annotated) is hereby amended by creating a new chapter

3 8 entitled: "Voluntary Relinquishment of Congressional Seat

4 Mandate".

5 Section 2. Chapter 8 of title 3 of the Code of the 6 Federated States of Micronesia (Annotated) is hereby amended by 7 inserting a new section 801 to read as follows:

8 "Section 801. Voluntary Relinquishment.

9 A member of Congress is considered to have voluntary

10 relinquished their congressional seat upon failure to

11 attend two consecutive regular sessions of Congress."

12 Section 3. Chapter 8 of title 3 of the Code of the Federated 13 States of Micronesia (Annotated) is hereby amended by creating a 14 new section 802 to read as follows:

15 <u>"Section 802. Eligibility for Congress After Voluntary</u>
16 <u>Relinquishment</u>.

17 (1) A member of Congress that has voluntarily

1	relinquished his congressional seat under section 801 is
2	not qualified to be seated to fill a vacancy during the
3	same congressional term that they voluntarily
4	relinquished their congressional seat."
5	Section 4. Chapter 8 of title 3 of the Code of the
6	Federated States of Micronesia (Annotated) is hereby amended by
7	inserting a new section 803(2) to read as follows:
8	"Section 803. Notification.
9	(1) The Speaker shall notify a congress member whom
10	has failed to attend one regular session of Congress
11	that failure to attend two consecutive regular sessions
12	of Congress will result in voluntary relinquishment of
13	their congressional seat. The notification shall be
14	done in writing.
15	(2) The Speaker shall notify a congress member whom
16	has failed to attend two consecutive regular sessions
17	of Congress they have voluntarily relinquished their
18	congressional seat. The notification shall be done in
19	writing."
20	Section 5. Chapter 8 of title 3 of the Code of the
21	Federated States of Micronesia (Annotated) is hereby amended by
22	inserting a new section 804 to read as follows:
23	"Section 804. Declaration of Congressional Seat
24	Vacancy.
25	(1) The Speaker shall declare a congressional seat

1	vacant where a member of Congress has voluntary
2	relinguished their congressional seat under section
3	801. The Speaker shall declare the congressional seat
4	vacant within 15 days of notification to the Congress
5	member under section 803(2).
6	(2) Upon the declaration of a congressional seat
7	vacancy under this chapter, the Speaker shall transmit
8	the declaration in compliance with subsection 3(b) of
9	Section 106 of title 9 of the Code of the Federated
10	States of Micronesia. Upon receipt of the declaration,
11	the President shall call for a special election in
12	compliance with Section 106 of title 9 of the Code of
13	the Federated States of Micronesia."
14	Section 6. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its
16	pecoming law without such approval.
